

VBS Mega Sports Camp Permission Form & Liability Waiver

I, the undersigned parent/guardian, do hereby grant permission for my son/daughter, named on this form: _____ to attend Mega Sports Camp. My child will be _____ years old during camp week. I fully understand that there is always a possibility that my child may sustain physical illness or injury while playing sports. I acknowledge and understand that my child is assuming the risk of such physical illness or injury by his/her participation, and I further release the sponsoring organizations (Harmony Community Church, Byron, Georgia) and its representatives from any claims for personal illness or injury that my child may sustain during the camp. I further acknowledge and understand that my child will be responsible for his/her failure to abide by the rules and regulations of the camp. If he/she needs a bandage, ice, etc, I authorize the safety coaches/nurse-supervised to help my child. If other injury occurs, I understand that the camp directors will attempt to contact me at the emergency numbers I have provided on this form, and that I am asked to be reachable at all times at the numbers provided. However, if I am unreachable, I hereby authorize the camp staff and representatives to act on my behalf should an injury occur. In order that my child may receive the proper medical treatment in the event that he/she may sustain injury or illness during MEGA Sports Camp, I hereby authorize the camp staff to obtain or provide medical treatment for my child for such injury or illness during the camp, and I hereby hold the camp staff and sponsoring organizations, as well as its representatives, harmless in the exercise of this authority. I further acknowledge and understand that I will be responsible for any medical bills that may be incurred on behalf of my son/daughter for physical illness or injury that he/she may sustain during camp.
